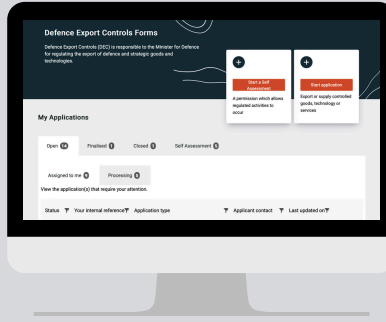




LEARN ABOUT THE **MADE** PORTAL

My Australian Defence Exports (MADE) portal is a new digital platform designed to **streamline** the **processing and management of Defence export applications in Australia**. It serves as the central location for submitting and managing Defence export permits and applications.

HOW TO USE THE **MADE** PORTAL

1. Getting Started

- ➔ As an Australian resident, your primary form of access will be myGovID.
- ➔ Navigate to the ServiceConnect and continue with Digital Identity.
- ➔ If you have a different email address associated with your DCRN, you should register that email with myGovID, then use it to login.

2. Navigating the Portal

- ➔ **Dashboard:** View submitted applications, their status, and updates.
- ➔ **Application Forms:** Fill out and submit forms for Defence export permits and certificates.
- ➔ **Self-Assessment Tool:** Get guidance on permit requirements.

3. Submitting an Application

- ➔ Select the appropriate form, provide details about your activity, and submit it through the portal.
- ➔ You can track the status of your application on your dashboard via the Finalised Tab. Completed applications will have a Finalised Status.
- ➔ To find out if your goods are controlled, complete a self-assessment with the **Self-Assessment Tool**.

4. DEC Client Registration Number

- ➔ You can register for a DEC Client Registration Number (DCRN) on the MADE portal home page.

- ➔ If you have not previously engaged with DEC, you will first need to submit a Client Registration Form that will grant you a DCRN.
- ➔ Your DCRN will be activated within a few hours and the details will be emailed to you.
- ➔ You can view your DCRN information on your account under your 'Profile' section.
- ➔ Once your DCRN is activated, you can view and submit applications.
- ➔ You can also easily update your contact details.

5. Authorised AUKUS User Community

- ➔ **When updating or registering** for a DCRN, you can apply for an AUKUS Community membership or see your AUKUS community membership status.
- ➔ **To join as an AUKUS Authorised Users** in the AUKUS community, select "Yes" to joining as an AUKUS Authorised user (to access Australian AUKUS exemptions only). Your request to access Australian AUKUS exemptions will be submitted, and you will be notified of the outcome once the assessment is complete.
- ➔ **To become an Australian Authorised User**, select "Yes" under the full membership section. Complete the application, submit your DCRN, and your request will be processed. You will be notified once a decision has been made.
- ➔ **An AUKUS Authorised User** can export goods from Australia only. An **Australian Authorised User** can export goods from Australia, the UK, and the US, excluding items on the Excluded Technologies List (ETL) and the Australian Military Sales Program (AMSP) exemptions.
