Defence Legal is the in-house team that provides legal advice to the Australian Defence Force, the Minister for Defence, and the Department of Defence.

We have an integrated team of over 700 personnel, comprising of Australian Defence Force (i.e. military) lawyers and Australian Public Service (i.e. civilian) lawyers, paralegals and non-legal support staff.

Pay and Benefits:

Our Australian Public Service lawyers receive:

- Competitive pay, with Graduate salaries starting from the Australian Public Service 4 Level + 15.4% superannuation (refer to the <u>Defence Enterprise</u> <u>Collective Agreement 2024</u> to view salary amounts).
- Opportunities for:
 - o annual pay increases;
 - o performance-based bonuses; and
 - an additional 10% remuneration on top of the salary, via a Building Defence Capability Payment.
- Funded Practical Legal Training.
- Funded Practising Certificates and memberships to the relevant Law Society.
- A work laptop to facilitate working from home.
- Generous leave provisions, including:
 - o 20 days of annual leave;
 - o 18 days of personal/carers leave;
 - o 18 weeks of paid parental leave;
 - o an additional day of Defence leave per calendar year; and
 - o paid 'stand down' leave during the Christmas and New Year period.
