Key Messages

- Australia has not supplied weapons to Israel since the conflict began, and for at least the past five years.
 - Since 1 January 2019, Australia has issued 247 permits to Israel, 66 remain active.
 - 23 of the 66 active permits support ADF capabilities.
 - The remaining 43 permits cover a broad range of parts, components, and dual-use technology that have legitimate commercial use.
- Since 7 October 2023, Defence has approved two export permits to Israel, which have now expired.
- · Australia has a stringent export control framework, which is designed to prevent the irresponsible or illicit trade of military and dual-use items.
- Defence continues to assess defence export applications to Israel. Each export application is assessed on a case-by-case basis to determine whether it would be prejudicial to Australia's national interests.
- A permit would be refused if there is an overriding risk that the export may be used contrary to Australia's national interest.

If pressed: What has Australia sent to Israel?

- While I can't go into the details of individual permits, I can give you an overview of defence export permits issued to Israel over the past five years.
- Since 2019 Australia has issued 247 permits to Israel, only 66 remain active.
- Of the 66 active defence export permits to Israel, about 35 per cent (23) support Defence projects and capabilities.
 - These include the Air Warfare Destroyer, the Hunter Class Frigates, the Battlespace Communications System (LAND 2072), the Hawkei Protected Mobility Vehicles, the Boxer Combat vehicles, and the Joint Air Battle Management System (AIR6500), which is a foundational element of Defence's Integrated Air and Missile Defence capability.
- The remaining 65 per cent of current permits (43) cover a range of parts, components, and technology exports.
 - These include a range of dual-use ICT hardware and software upgrades with legitimate commercial use s47E(d) , and the return of equipment to original manufacturers in Israel for repair and return back to Israel permanently s47E(d)
 - Other existing permits cover a variety of items including various electronic componentry, cooling equipment and radios.

- Both of these permits have now expired.
- Defence does not comment on individual exports due to legal, privacy and commercial-in-confidence obligations.

- The Department of Foreign Affairs and Trade data was collected by the Australian Border Force and compiled by the Australian Bureau of Statistics.
- This data is based on information provided by companies about the type and estimated value of goods as they leave Australia.
- In declaring the type of goods they are exporting, companies select from a list of broad categories - one of which is 'arms and ammunition'.

- Defence has confirmed that all goods referred to in the reported data were exported with relevant permits. As such, I can confirm that Australia has not supplied weapons to Israel since the conflict began, and for at least the past five years.

If pressed: How can Defence previously advise that 322 export permits have been granted to Israel since 2017 while also claiming no weapons have been sent to Israel for the last five years?

- Australia's export control framework applies to a wide range of goods and technology, including items used for civilian and commercial purposes.
- . The Defence and Strategic Goods List is over 300 pages long and captures a variety of goods, software and technology. There are over 2,500 unique item codes listed on the Defence and Strategic Goods List and the overwhelming majority are dual-use items.
 - 2,184 item codes are categorised as dual-use and 392 as military items.
 - Items categorised as dual-use have legitimate civilian applications.
 - As a result, the existence of an export permit from Defence should not be conflated with the export of weapons.
- Permits are required for a range of goods such as radios, lasers, software, electronics, vehicle parts, repair and return of components, all listed on the Defence and Strategic Goods List.

If pressed: can Defence confirm whether Australia is supplying F-35 parts or components to Israel?

- . I am not going to comment on individual permits.
- . However, Australia has been a participant in the F-35 program since 2002.
 - Australia is one of 18 participants, including Norway, Denmark, Canada and the Netherlands, who operate the F-35 and contribute to its global supply chain.
- The F-35 is a critical part of Australia's national security architecture
 - The bulk of the Royal Australian Air Force's fast-jets are F-35s.
- Australian industry provides F-35 parts and components to Australia and other F-35 global supply chain customers.
 - The supply chain and the sale of F-35 parts and components is managed jointly by Lockheed Martin and the United States Government.
