Tax Invoice	Clause 11.5(b) and corresponding Contract Particular	Amendment to provide that the Contractor must give Defence Invoicing (as well as the Contract Administrator) a tax invoice for the amount stated as then payable by the Commonwealth to the Contractor in the payment statement, rather than a copy of the tax invoice.
Shadow Economy Procurement Policy Connected Policy	Clause 17.14	Amendments to reflect updates to the Shadow Economy Procurement Connected Policy, including to clarify that the Contractor must not enter into a subcontract with a subcontractor or subconsultant unless the Contractor has obtained and holds the STRs required for the relevant subcontractor's or subconsultant's entity type.

Environmentally Sustainable Procurement	Clause 17.18	Amendments to reflect updates to the Environmentally Sustainable Procurement Policy, including to:  • require the Contractor to use the ESP Policy Reporting Template for "Construction Services" and, if applicable, the ESP Policy Reporting Template for "Products" when completing and submitting its report under clause 17.18(g); and  • consequential amendments, including the insertion of new definitions and the removal of definitions for terms no longer used.
