The Australian Signals Directorate (ASD), in collaboration with international partners, has released guidance for critical infrastructure owners and operators on integrating AI into OT environments. #### **Procurement Changes**

### **Environmentally** Sustainable **Procurement Policy**

#### The **Environmentally Sustainable Procurement (ESP) Policy**

expansions, in effect from 1 July 2025, now applies to 3 additional categories for Australian Government procurements with an estimated value at or over \$1 million:

- Textiles
- Furniture, fittings and equipment
- Information and communication technology goods.

This is in addition to procurement of construction services valued at or above \$7.5 million.
