**1. INVITATION TO REGISTER INTEREST**

Environmentally Sustainable Procurement	Clauses 2(c)(i)C and 25(b)(i)	Amendment to align with the updated Medium Works Contract Tender Documents minimum form and content requirements.
Industry Inclusion and Skills	Clause 2(c)(ii)E	Amendments to align with the updated 'industry inclusion and skills' evaluation criterion in the template Medium Works Contract Tender Documents.
Joint Bids	Clause 8.2(b) and Registration of Interest Form	Amendment to clarify that Applicants submitting on a Joint Bid Basis should provide, as part of its Registration of Interest, any information relevant to its proposed joint bid arrangements and each entity comprising the Applicant.
DISP Membership	Item A (Defence Industry Security Program) of Schedule C – Information Security	Amendment to request the Applicant provide evidence of DISP membership (in the form of a certificate issued by the Commonwealth) together with details of the relevant level held for each Security Domain.

Joint Bids	Clause 11.3(b) and item 12 of the Tender Form	Amendment to clarify that Tenderers submitting on a Joint Bid Basis should provide, as part of its Tender, any information relevant to its proposed joint bid arrangements and each entity comprising the Tenderer.

Tax Invoice	Clause 11.5(a) and corresponding Contract Particular	Amendment to provide that the Contractor must give Defence Invoicing (as well as the Contract Administrator) a tax invoice for the amount stated as then payable by the Commonwealth to the Contractor in the payment statement, rather than a copy of the tax invoice.

Australian Skills Guarantee	Clauses 18.21 and 24.1	<p>Amendments to reflect updates to the Australian Skills Guarantee Procurement Connected Policy, including to:</p> <ul style="list-style-type: none"> <li>require the Contractor to submit a Skills Guarantee Report via the Skills Guarantee Online Reporting System (rather than using the previous Skills Guarantee Reporting Worksheet);</li> <li>require the Contractor to submit Skills Guarantee Reports at the intervals specified by the Skills Guarantee Online Reporting System, provided that if no such intervals are specified then the intervals in paragraphs (d)(i) to (iii) apply; and</li> <li>consequential amendments, including the insertion of new definitions and the removal of definitions for terms no longer used.</li> </ul>
Lessons Learnt Workshop	Clause 18.22	Amendment to insert a new clause 18.22 which provides that the Contractor must prepare for, attend and actively participate in a lessons learnt workshop to be held after Completion of the Works.
Asbestos	Clause 24.1	Amendments to the definitions of 'Asbestos Management Plan', 'Asbestos Related Activities' and 'Work Health and Safety Plan' to reflect the updated Security and Estate Group Asbestos Management Plan.
Regional Base Services Contractor	Clause 24.1 and various	Amendments to replace the definition of and references to 'EMOS Contractor' with 'Regional Base Services Contractor'.
General	Various	Further amendments, including minor drafting and tidy-up amendments and consequential amendments.
