Dear all,

Thank you for your department's assistance on the area declaration processes for the recent Portland area, and previous Gippsland and Hunter areas. As you may have seen, the public consultation process for the Hunter region ended in April and the Offshore Renewable Energy team is continuing to work on additional area declarations.

We are now beginning the area declaration process for a proposed area in the **Pacific Ocean offshore from the Illawarra region**. Currently the Minister is looking to announce the opening of public consultation for proposed area off the Illawarra region in August 2023.

Our team has undertaken an initial review the major constraints in the area and attached is a preliminary area for your consideration.

Your department's knowledge of existing users, activities, and stakeholders in the vicinity of the preliminary area is essential. It will assist our team in understanding whether the area could be suitable for offshore renewable energy projects - in particular, the installation, operation and decommissioning of offshore wind projects.

We are seeking your feedback to refine the area prior to seeking Ministerial approval to commence public consultation. **We are requesting your feedback by COB 30 June 2023.**

For this initial feedback, we are specifically looking for any areas to exclude from the proposed

area. We can continue to discuss other risks, sensitivities and issues related to the area as well as any conditions that may be required on licences in the area through the public consultation phase.

Once we have received feedback from all relevant Government stakeholders, and any required changes are made, the revised area will be circulated to you. We will hold an Inter-Departmental Committee meeting in July, with representatives from all departments/agencies we are seeking feedback from, to confirm support for the proposed area, prior to us seeking Ministerial approval to commence public consultation.

Please note that there has not been a public announcement in relation to the Illawarra region. This **information, including maps, is to be kept confidential** and not shared beyond those relevant to this request.

We will be in contact with you shortly to set up a meeting, if needed, for more discussion on the preliminary area.

Thank you for the opportunity to provide feedback on the Department of Climate Change, Energy, the Environment and Water’s (DCCEEW) proposed Illawarra Offshore Wind Farm Area. I understand the Minister for Climate Change and Energy, the Hon Chris Bowen MP, has powers under the *Offshore Electricity Infrastructure Act 2021* (OEI Act) to declare offshore areas as suitable for offshore renewable electricity infrastructure. I also understand the Minister wishes to begin public consultation with regards to this area in the first week of August 2023.

In response, I have drafted the advice below to assist in demonstrating the complexities of the proposed area and its interaction with Defence operations. I would like to preface this advice by noting that a number of Defence stakeholders are currently engaged in Exercise TALISMAN SABRE 2023 and were unavailable to provide more detailed comments in the time available. As such, some additional input with regard to the full effect of wind turbines on Defence capability is still required and will be provided in due course.
