#### **Executive Summary:**

As the Australian Prime Contractor for the F-35 Air Vehicle Support Services (AVSS) Contract, we have developed our solution to maximise the Australian Industry work share to the greatest extent possible whilst delivering a cost effective program to the Commonwealth of Australia (Commonwealth).

The services undertaken under the contract with the Commonwealth include the following activities:

- Support Services Management
- O+ Maintenance
- General Use Consumables (GUC)
- Retail Warehouse and Logistics Support.

BAE Systems Australia Limited (BAE Systems) has committed to deliver the aims of the program, which are to provide value for money, and meet the current and future Australian Defence Force and Industry capability requirements. The key contract enabler is the provision of increased certainty of work for industry that delivers the ability to reduce costs over the contract period. Therefore, BAE Systems has established arrangements with the following subcontractors based on their previous experience, their commitment to the aims of the program, schedule adherence and value for money. 27% of the contracted services will be delivered by Australian Industry other than BAE Systems.

The services for AVSS will be provided via Contract Number CASG/ASD/Con14506/1 with an initial contract term of 60 months. The overall contract price is \$74.15M, of which approximately AU\$59.04M will be delivered by Australian Industry which includes BAE Systems.
