Executive Summary

The Department of Defence (Defence) has established the One Defence Data Program (the Program) to ensure Defence becomes a more data-informed organisation that better leverages information and data for strategic and operational advantage. KPMG Australia Technology Solutions Pty Limited and its consortium (Team KPMG) has been selected as the preferred Systems Integration supplier for Tranche 1 of the Program. KPMG Australia Technology Solutions Pty Limited is a wholly owned and controlled subsidiary and affiliate of KPMG, an Australian partnership.

The overall value of Tranche 1 of the Program is \$233M AUD, of which approximately \$86M will be delivered by Australian Industry. Work will commence under this contract from May 2022, and Tranche 1 delivery is expected across a two-year horizon. Service delivery locations are in Canberra and Melbourne, in both KPMG offices and Defence establishments as directed by the Commonwealth.

The work packages scope of work to be delivered under this contract include:

- Master Data Management: Leverage Oracle Master Data Management capability with Alation data catalogue
