- 2. Further, ATS will define and deliver the ASDEFCON Support System Constituent Capabilities (SSCC) services to the Commonwealth, including support for the range operators to enable Army and international allies to achieve their capability outcomes.
- 3. The ILTS program includes five SSCC as detailed below:
 - 3.1. Operating Support,
 - 3.2. Engineering Support,
 - 3.3. Maintenance Support,
 - 3.4. Supply Support, and
 - 3.5. Training Support
- 4. As a 100% Australian owned and operated Capability Systems Integrator (CSI) located in regional NSW, ATS currently employs and will grow, develop, train, and sustain its existing Australian work force to successfully deliver the ILTS program and further develop ATS to become a world leader in live fire training capabilities.
