## **Executive Summary**

## Background

Royal Wolf has been contracted by the Commonwealth of Australia to design and manufacture Personnel Restraint Modules (PRM), under Project Land 121 Phase 3B/5B Medium Heavy Capability, to be utilised for the safe transport of Defence personnel on 40M Mediumweight Trucks (40M/C and 40M with and without crane). The PRM will be utilised in the "Raise, Train & Sustain" roles and operations including: Defence Aid to the Civil Community, Humanitarian and Disaster Relief and select operations within non-warlike environments.

The major deliverables of this contract (No. CASG-LSD-Con12014.1), are:

- design and development including engineering drawings, models and testing;
- manufacture and fitout of 300 PRMs;
- provision of spares for the life of type of the PRM;
- operator training;
- maintenance requirements determination; and
- user handbook and technical publications.

Under the contract, Royal Wolf will be engaging Australian industry for the majority of the product components required. Royal Wolf remains committed to ensuring Australian industry has the opportunity to compete on merit for all items identified for potential procurement in Australia. The contract involves: design, development and production of specific hardware such as modules, sub-systems and components; project management; systems integration; and developmental, test and evaluation. This Public AIC Plan will remain in place for the duration of this contract; final deliverables are scheduled for 2025.

The contract price is \$46,447,333 (exclusive of GST), of which approximately 74% will be delivered by Australian Industry equating to a total Australian Contract expenditure of \$34,474,190; the "Local Industry Activities" value of this is \$28,281,136.



# Key Offerings for Australian Industry

For over 25 years, Royal Wolf has prided itself on engaging local industry leading suppliers to develop Australian capability and support our domestic economy. We will continue to support local industries under the umbrella of the contract. Several Australian companies have contributed to our tender response through the provision of industry expertise and advice, and, therefore, these entities have been shortlisted for inclusion in the procurement process.

As the PRM remains under development and is presently at concept design stage, no Australian companies have been contractually engaged at this time. The design, development and production of this product will be delivered through our Brisbane (Banyo) engineering and production facility, whilst testing facilities located interstate will be engaged to undertake specific specialised tasks.

# **Scope of Future Opportunities**

As this contract includes "Through Life Support" of the final product and may present export opportunities for production of similar solutions, we expect engagement with local Australian companies and suppliers to extend for the decade beyond the initial product life deliverable.

Royal Wolf has developed a specialist technical engineering team dedicated specifically for the engineering, design and development of modified containerised solutions. The skill set and capability of our team enables Royal Wolf to control the majority of Project Management functions. Royal Wolf regularly assesses and monitors current supply chain providers and opportunities. It is our intention to provide domestic market opportunities to ensure we assist in developing sovereign capability to support the Australian Defence Force long-term.

Royal Wolf recognises the importance of supporting Indigenous Australian businesses and has engaged with Supply Nation to identify local indigenous businesses that could provide support to this project and ensure potential suppliers are given the opportunity to compete for the supply of products and services. Further to this, Royal Wolf intends to employ two additional apprentices to perform work under the PRM contract and will seek to to provide these opportunities to indigenous youth.

Additionally, we are currently working with ARG Workforce, a supplier of labour for projects. ARG is part owner of a joint venture indigenous recruitment company, Karlka Recruiting Group Pty Ltd (KRG). KRG is Supply Nation registered as a majority owned indigenous company.
