1. EXECUTIVE SUMMARY:

- 1.1 The contract with RCA is for the procurement of and support services to quantity eight DTCS TS at various ADF locations within Australia. The contract with RCA is for the procurement of and support services to quantity eight DTCS TS at various ADF locations within Australia. The combined Contract value is approximately \$40M of which approximately \$32m will be spent in Australia.
- 1.2 The Australian Industry Capability (AIC) Plan provides the Contractor's plans, procedures and responsibilities for the management of AIC for the duration of the Contract. The Contractor uses the AIC Plan to manage, coordinate and monitor the delivery of the AIC program.
- 1.3 The Commonwealth uses the AIC Plan to:
 - a. Evaluate the AIC program; and
 - b. Identify the Commonwealth's involvement in the AIC program.
- 1.4 RCA is contracted to provide:
 - a. Prime system integration.
 - b. Installation of the system hardware at the designated ADF locations.
 - c. Develop the integration software to allow the Joint Fires equipment to operate with in the DTCS Training System environment.
 - d. Support and maintain the DTCS Training System.

Estimated contractor value is \$18m

- 1.5 Virtual Simulation Systems is subcontracted to RCA to:
 - a. provide the simulation engine;
 - b. design and develop the DTCS Training System hardware;
 - c. design and develop the Simulated Military Equipment; and
 - d. provide ongoing software and technical support.

Estimated subcontract value is \$13m

- 1.6 The estimated value against RCA's major equipment suppliers is \$9m
- 1.7 Approximately 80% of the above work is to be performed in Australia.
- 1.8 The Industry requirements are detailed in the table below.
