## **Key Points**

- Former Minister for Defence, the Hon Christopher Pyne's new consulting job in the defence sector is being criticised as being in breach of the rules on postministerial employment.
- The Department of the Prime Minister and Cabinet administers the Statement of Ministerial Standards and the Lobbying Code of Conduct.

# **Talking Points**

- What Mr Pyne chooses to do post his ministerial employment, or ministerial code of conduct matters are not Defence issues.
- Rules governing elected or former elected officials are established outside of Defence.
- Defence will continue to enter into contracts where appropriate and in compliance with relevant Government legislation, policy and rules.
