## **Key Issues**

- As per your direction on 21 May 2021, the Secretary and the Chief of the Defence Force (CDF) issued a direction outlining that Defence must at all times be focused on our primary mission to protect Australia's national security interests, and any effort into matters that distract from this are not required and must cease.
- Moving forward, and in line with the above, Defence proposes to acknowledge the events listed at <u>Attachment A</u>. With your agreement to this approach, Defence will then release a Secretary and Chief of the Defence Force Joint Directive outlining how these events will be acknowledged, allowing for appropriate planning and communication of these events.
- To achieve Defence's objectives and build capability, these events of significance are proposed on the basis of four categories: national commemorations, culture, workforce and families.
   The events within each category reflect Australian Government policy or long standing Government/Defence support.
- 4. Defence proposes the following points will direct how the events at <u>Attachment A</u> will be planned and executed:
  - Participation is not to detract from the development or delivery of Defence capability.
  - Participation is to be consistent with ceremonial and dress manuals and other extant guidance.
  - Participation is to be consistent with Defence values and behaviours.
  - Consumption of Defence resources to be commensurate with the significance of the event and appropriate expenditure of public monies.
  - Events are to be inclusive and open to all personnel, subject to operational requirements.
  - The conduct of the activity should reflect positively on Defence's reputation.

To ensure compliance with this approach, the Secretary and CDF have directed that all
planning and communication materials supporting days of significance or related issues on
diversity and inclusion must be approved by the Associate Secretary.

# **Background**

- 6. Each year Defence has identified a range of events, including national commemorations, which are acknowledged at an enterprise level. To date, these have been approved by the Enterprise Business Committee, chaired by the Associate Secretary. They have been chosen on the basis of national commemorations, events of significance, and events of importance.
- 7. Defence also undertakes a number of additional high profile community engagement activities which have been identified to provide significant community exposure. These are approved by yourself on a six-monthly basis, with the latest being MS21-000884 High Profile Public Event Program Jun Dec 21, signed by yourself on 20 May 21.
- 8. Defence Groups and Services also participate in, or contribute towards, smaller localised events designed to improve community engagement. Defence's participation in these events assist with public awareness, attracting, recruitment and family support activities.
- Defence participation and engagement with all community events are managed in accordance with Joint Directive 02/2021 – Defence Engagement with the Australian Community.

# Consultation - internal/external

- Defence has consulted with other government departments. The proposed approach is aligned with other agencies, noting Defence gives greater weight to military commemorative activities.
